As the Direction and Guideline given by the University Grants Commission, Dr.Babasaheb Ambedkar Marathwada University and Director of Higher Education authorities the college has constituted the Anti Ragging Committee in the year 1992 to prevent the menace of ragging and maintain healthy inter personal relations among students in the college campus Prof.S.N.Morey as a coordinator taken lead to establish various committees to implement the Law of Anti .Ragging. At the beginning of the Academic year the committee members were nominated for smooth functioning.

For Academic Year 2018-19 under the chairmanship of Dr.C.M Rao, Principal and Dr.S.G.Shirsat, Coordinator Anti Ragging Committee and Anti Ragging Squad and Mentor Cell is established. The Anti Ragging Committee meetings frequently conducted and various issues pertaining to discipline in and out the campus discussed and suggestions were followed. Anti Ragging is strictly prohibited and forbidden in or out side the college campus. For this purpose the Anti ragging Committee has been actively functioning.

In the academic year 2018-19 all the college student are informed about anti ragging through prospectus. Near about all the students filed their anti ragging affidavit form online and submitted to the college office.

Measures taken by institute:

As per the direction of the UGC the College has taken measures since its inception. The revisions are made regularly as and when required according the guidelines.

1. Lecture on Anti ragging by Members.

All full time faculties are appointed as a mentor of each class and as and when necessary given instruction to all students to create awareness about Anti Ragging Movement.

2. Orientation and lecture to the students and parents

The College also conducted parents meet and tried to solve the grievances if any.

3. Fresher's day for the students-

The admissions of LL.B. I year 3 year and B.A.LL.B. 5 year course students are made by three CAP rounds. At the beginning of commencement of classes all the fresher's introduction and meeting conducted.

4.Banners and Posters

Slogans and cautionary boards displayed inside and ourtside the college building with all the helpline numbers and members Name and Cell number of Anti Ragging Committee, Anti Ragging Squad etc.

- 6. Anti ragging Squad Who do surprise checks in the Boy's hostel and Girl's Hostel, Library.
- 7.. CCTV cameras are present at all vital points inside the class room, corridors and outside .

- 9. Anti ragging Mission functioning and updates available on College Website.
- 10. Four short films released by the UGC on Anti ragging were shown to all the students.
