

➤ ***Dates of the Competition:-***

The XV National Moot Court Competition was held on 24th & 25th January 2015. The said dates were already determined in a meeting of staff at the end of last academic year.

➤ ***Moot Court Problems or Moot Propositions:-***

So far as Framing of Moot Court Problem or Moot Proposition is concerned, we make innovative changes from time to time. In the last year XIV Moot Court Competition, we had invited problems from teachers, advocates, students from all over the India and had selected 2 problems for the competition by appointing a Selection committee consisting of Hon'ble Retired Judges of High Court and Leading Practitioners.

This year we have received 2 Moot Propositions from the Vaish Associates, New Delhi a law firm for Preliminary round and final round respectively.

➤ ***Sending Invitations to Participate:-***

The process of sending Invitations through email to participate in the said competition was started in the month of October 2014. We have send invitation through email around 2000 Law colleges and universities in India. We have sent the same thrice on different dates.

We have also sent the hard copies of Invitation to 500 Law colleges and universities in India in the first week of November 2015. We have appointed one student coordinator for sending invitations through email.

➤ ***Formation of Committees of Student Volunteers:-***

After sending Invitations we have circulated a notice in College to all the students who are interested to act as Volunteers in the said Competition. We received overwhelming response from the students as nearly 70 students shown their keen interest. But requirement was of only 30 students, hence we along with

respected Principal Dr. C. M. Rao and Staff in a meeting selected 30 students on the basis of their Class attendance, Sincerity, Discipline etc. These 30 students have been shouldered with works in different committees such as Accommodation Committee, Publicity Committee, Court Hall Management Committee etc. The list of the said students has been enclosed herewith for your kind perusal.
