- d) Inclusion of Audio/ Video effects, excellent use of power point skill and techniques
- e) Conclusion

The first screening round of competition was completed on 12th January 2015 under the able examination of **Dr.(Prof) B.V. Paranjape**, faculty of M.P. Law College and **Dr.(Prof) SushamaChandorkar** Department of commerce of IBP Mahila College Aurangabad. For maintaining secrecy and to avoid any kind of bias every team was allotted with the Specific code.
