



**Report of XXIII National Moot Court Competition**  
**2022-23**

In this academic year, our college has conducted XXIII National Moot Court Competition in March 2023. Report of the same is as follows:

**Dates of the competition:**

Every year we conduct this competition in two rounds i.e. preliminary and final. This year competition was rescheduled on 25<sup>th</sup> & 26<sup>th</sup> March 2023. The said dates were already determined in the meeting of the staff at the end of last academic year.

**Moot Court problems:**

This year we received Nineteen Moot problems which were then sent to selection committee consisting of Hon'ble retired judge of High Court and leading practitioners in Aurangabad. Selection committee had selected two problems. Moot problem framed by Mr. Abhishek Nagtilak, Student DGB Dayanand Law College, Solapur was selected for preliminary and semifinal round and moot problem drafted by Mr. Asim Sayyed, Student DGB Dayanand Law College, Solapur was selected for final round.

### **Mode of the competition:**

Competition was conducted in Three rounds i.e. Preliminary, Semi-Final and Final Round. In all these rounds one speaker from a team has to argue against the speaker of another team. It means it was not a competition as team but as an individual.

### **Preliminary round:**

Preliminary round was conducted in college building. For this round five court halls were arranged and in three court hall four and in two court hall three teams with unique code were distributed by drawing the lots. Each court hall was consisting of two judges. The judges are the leading legal practitioners in Aurangabad. This round held on 25<sup>th</sup> March 2023.
