1. About Moot Court

Manikchand Pahade Law College, Aurangabad is the oldest law college in Marathwada region. M.P. Law college occupies important place in educational circle of Marathawada region and is affiliated to Dr. Babashaeb Ambedkar Marathwada University, Aurangabad and Bar Council of India, New Delhi. Moot court activity is the prime activity of the institution. Special budget of 3 lakh 50 thousand rupees is allocated for this activity. Being the institution is established by lawyers of first generation of Marathwada region through Marathwada Legal and General Education Society, it has special attention and focus on development and nourishment of legal professional skills in students. With a view to organize, conduct and promote the Moot Court Activity, the institution has started Moot Court Competition. Earlier competition was organized at State level for 25 years, after receiving a grand success and positive response from the legal fraternity, it is being organized at National Level from last 23 years.

4. Moot Court Association

Every year Moot Court Association is constituted. The interested students of all classes enroll in moot court association. From the association the student Convenor, Co-convenor and Class representatives are chosen. There is a Student Committee for National Moot Court Competition and Intra Moot Court Competition. Orientation and training to the students of association is given regarding moot court activities and they are informed about their role and responsibilities. Meetings are conducted at regular intervals to conduct all the activities smoothly.

Role of moot court volunteers in Competitions

- The moot court association volunteers with commitment work for the grand success of the event.
- They are instrumental in helping the participants to reach the institutes and take care of necessary hospitality in organization of National Level Moot Court Competition.
- > They help in registration of participants in competitions.
- Court decorum is created and maintained during the Preliminary and final round of the competition.
- Two students escort the judges who carry briefs of the judges to the court hall.
- Two students work as court clerks take care of time and after the allotted time show the signboards to the participants and audience without disturbing the silence of the court hall.
- Students call the team code in advance.

8. National Moot Court Competition

Evey year National Moot Court Competition is organized. This year the college will be organizing XXIV National Moot Court Competition. The unique feature of National Moot Competition is that the moot propositions are invited from legal fraternity. The received moot propositions are sent to the panel of Judges to select two propositions one for Preliminary, semifinal and other for Final round of Competition. Earlier this competition was organized for the students in two rounds Preliminary and Final Round. From academic year 2021 -22 the competition is conducted in three rounds i.e., Preliminary, Semi Final and final round. Preliminary round is assessed by the leading practitioners of High Court and District Court and final round is assessed by the Hon'ble Judges of the High Court. The students get opportunity to argue before seating/ retired judges of High Courts. This competition is organized in transparent methods, with responsive and committed conduct of organization. Complete court decorum is maintained. Innovative practices adopted during organization, such as Nationwide open invitation of moot problem, participation of students from different states, LCD live performance of the competition.

Since inception of the practice of National moot court competition the institute is keen over the transparency and committed towards the organization. For maintenance of transparency and fairness in the competition each team is provided with the team code and identity of the participant or the institute to which they belong is kept confidential. After the preliminary round all participants are communicated the result of assessment and the same is also mailed to the institutes to which they belong if requested by the participant teams.

11. Moot Court Hall

Final round of the National Moot Court Competition used to be organized in the Marathwada Legal and General Education Society's Tapadia Natya Mandir with the seating capacity of 650 students. The students of our institution as well as other law colleges in the city are invited to witness final round of the competition. Now, the Institution is having a Moot Court Hall with a capacity of 175 students. The Moot Court Hall was inaugurated on 25th October 2023 by the auspicious hands of Former Chief Justice of India, Hon'ble Justice Sri U.U. Lalit. The moot court is named in the memory of Late L.S. Kulkarni Memorial Moot Court Hall. The CSR fund from CTR Manufacturing Industries Private Limited was utilized for making Moot Court Hall. The Moot Court Hall is having all modern facilities. It is acoustic with International Patent Design and equipped with LCD for live performance of the event. It is having separate chamber for Judges *etc.*
