Dear Students,


At the outset, I have the privilege to welcome you all to this great temple of learning.

The Marathwada Legal and General Education Society's Manikchand Pahade Law College witnessed a seminal event in the Memory of Late Adv. Vishnupant B. Adwant on 2nd December 2018, having



Shri. Swami Chidananda an Engineer by education, transitioned to be a speaker, writer and a teacher of spiritual topics for nearly three decades as the Chief Guest for the event.

Adv. R.D. Deshpande, President of the M.L. & G.E. Society was the Chairperson of the event. The programme commenced with the appropriateness of tradition by lighting the lamp and garlanding the portrait of Maa Saraswati and Late Adv. Vishnupant B. Adwant followed by Saraswati Vandana by Mr. Vishwanath Dashrati.

Principal of Manikchand Pahade Law College Dr. C.M. Rao introduced the College and the achievement marked by the students due to the tireless efforts of Management and Staff.

Advocate Shrikant Adwant delivered his introductory speech for his intention behind the institution of the Lecture series in the memory of his father.

The topic for the lecture was "THE CONTOURS OF LAW AND MORALITY IN THE INDIAN SOCIETY". Shri. Swami Chidananda enlightened the audience from cross-section of the society and

students by providing deep insight into the topic.

In his address, Shri. Swami Chidananda, invited the attention of the august audience to the fact that while 'laws' maybe of professional interest to those involved in the legal profession, 'laws' were made by lawmakers, who were in fact entrusted by society – and that, ultimately both law and morality was of interest to all humanity.

"Over time and throughout history, there was always a divergence and a difference of opinion in the interpretation of laws", added Swami Chidananda.

Taking the example of Bhagat Singh, Swamiji pointed out that while we Indians saw him as a freedom fighter, the British saw him as a terrorist – it appeared as if the eyes of morality and the eyes of law tended to go in opposite directions. In the name of religions, the world had seen bloodshed. Divisions drove strife between nations, between religions, and even between families and human beings.

Swamiji quoted Thich Nhat Hanh, the Vietnamese Zen Master who has said that miracles were not in flying or in walking on water. The real miracle was in walking on earth with peace in the heart.

"The constitution, the books of law, the lawyers and the judges are very necessary on one hand; religious teachers who explain their holy books are also necessary for any society on the other", added Swami Chidananda.

Quoting Sri Krishna in the Bhagavad Gita: swadharme nidhanam shreyaha paradharmo bhayawaha (3/35)... Swamiji asked that we discover where our true skills lie. To find out our true temperament, and not get carried away by fancies or passing fads. The erudite and well-read Police Commissioner of Aurangabad, Chiranjeev Prasad later appreciatively commented that he was very happy to hear Swamiji's interpretation of the shloka, since it has often been misrepresented in a narrow manner that suggests one should follow only one's own religion, and stay away from other religions.

The event was concluded by Vote of thanks proposed by Mr. Harish Adwant expressing earnest gratitude towards the august gathering from cross-section of the society for their presence in the event.




